

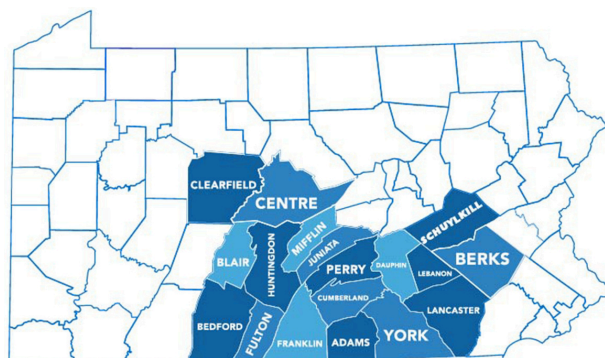
### Our Mission

The Pennsylvania Legal Aid Network provides 44.1% of our funding from various sources including, Interest on Lawyer Trust Accounts, state and federal Title XX, filing fee add-ons, and the Disability Advocacy Project. The Legal Services Corporation provides 27.2% of our funds. Additional support comes from the Dauphin County Bar Association, Domestic Violence Services of Cumberland & Perry and individual donors.

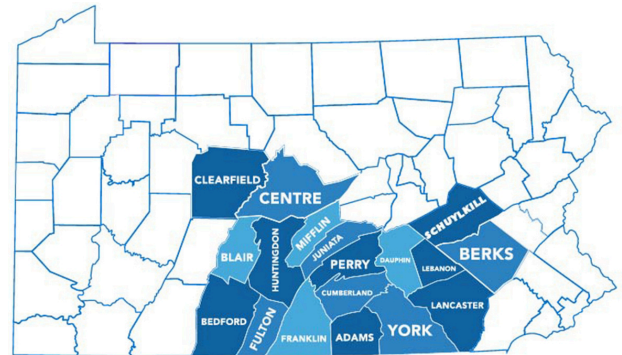
