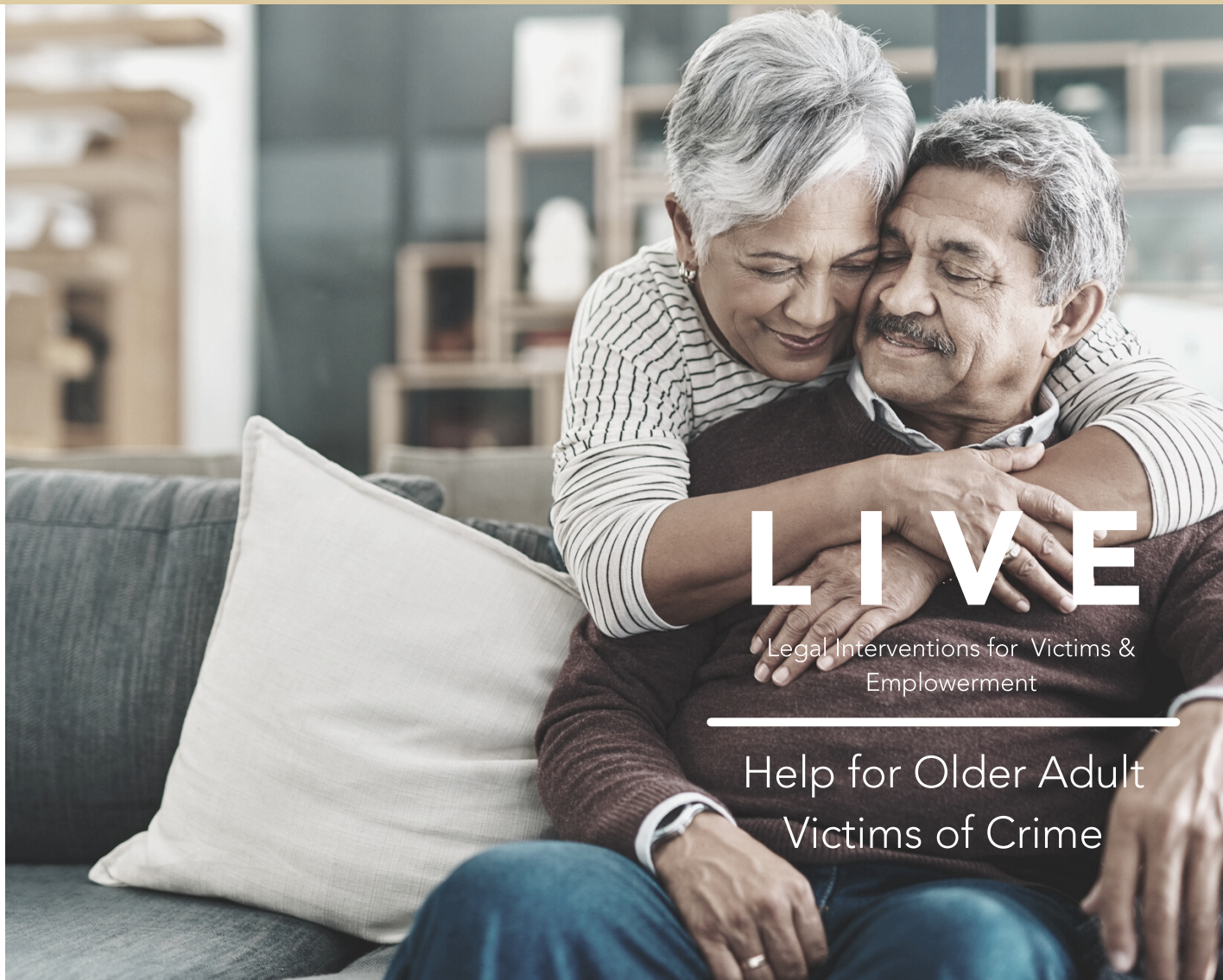

## WHAT IS LEGAL AID?

MidPenn Legal Services is a 501c(3) non-profit law firm that receives funding to provide free civil legal services to low-income residents and survivors of domestic violence and sexual assault in 18 counties in Central Pennsylvania.

MidPenn provides legal advocacy to older adults who are or have suffered physical or financial abuse.

We can assist in many ways including obtaining protection orders after physical or sexual abuse, or intervening on behalf of the victim with creditors, landlords and other service providers after financial exploitation.



## WHO IS A VICTIM?

Have you:

- Been hit, harmed, or made to feel afraid around your spouse or other family members?
- Had a caregiver or family member steal money, medication, or valuables?
- Been scammed over the phone or by door-to-door or internet schemes?
- Had your identity stolen?

As a caregiver or concerned relative, have you:

- Met people who inappropriately take the older adult's money?
- Noticed an older adult suddenly retreat from long-term relationships and start to trust a person that is unknown to any family or friends?

## WHO IS ELIGIBLE?

Residents of Lancaster County aged 60 or older & victims of a crime such as identity theft, financial exploitation, physical or sexual abuse or any other civil legal issue which is a direct result of one of these crimes.

**You do not need to have called the police or file charges to get help.**

## WHAT HELP IS AVAILABLE?

Types of assistance may include:

- Protection orders from physical or sexual abuse
- Replacement of Power of Attorney or Guardianship
- Intervention with creditors or help with Landlord/Tenant issues
